OFFICE ORDER

In compliance to the Comptroller & Auditor General of India Letter No.181-Estates/11-2020 dated 02.07.2020, regarding Preventive measures to contain the spread of COVID-19 along with guidelines for Unlock-2, Ministry of Home Affairs Order No.40-3/2020-DM-1(A) dated 29.06.2020, regarding to re-open more activities in a calibrated manner, in areas outside the Containment Zones and to extend the lock down in Containment Zone up to 31.07.2020, Govt. of Nagaland Order No. CSO/GAB-I/COM/GEN-I/2020 dated 29th June, 2020, which ordered that all the existing guidelines with regard to the lockdown in all parts of the State issued vide order of even number dated 04.05.2020, subject to relaxation vide order dated 10th June, 2020 and dated 20th June, 2020 shall continue to remain operative in Nagaland till 15th July,2020, and in continuation of this office Order No.14 dated 02.06.2020, the Office of the Principal Accountant General (A&E) shall continue to remain fully functional until further orders, with following additional instructions.

- 2. If any, officials tested positive due to close contacts (family members, relatives staying in same home etc.), such officials are directed to promptly disclose the information to their respective sectional in charge/BO / Administration failing which such officials shall be liable for disciplinary action.
- 3. Officials who do not have their own conveyance may utilise the Bus service provided by the office.
- No station leave permission shall be granted as a matter of routine. The same will be granted only in exceptional circumstances. Any period of quarantine arising as a consequence of station leave shall have to covered by the official's leave.
- 5. Physical meetings/discussions/ consultations in the office premises should be avoided to the extent possible. Physical movement of files within the office and postal correspondence with other offices should be minimized. All officials are advised to work electronically as far as possible.
- 6. Annexure-I in regard to National Directives for COVID-19 issued vide the Ministry of Home Affairs Order No.40-3/2020-DM-1(A) dated 29.06.2020 is enclosed for strict compliance.
- 7. All the officers/officials (including outsourced staff) below the level of Branch officers of this office shall attend office on every alternate day as per the duty roster enclosed in Annexure-I & II, till 15-07-2020.
- 8. Further, the regulations/instructions issued by this office vide Order No.14 under No. ADMN/A&E/MIS/COVID-19/2019-20/ dated 02.06.2020,shall be continued until further orders. The same is to be strictly followed by all the officers/officials.
- 9. All officers and staff shall attend office and shall strictly follow all the instructions/orders of the Government, as violation of the lockdown orders would be taken as offence punishable under section 188 of the Indian Penal Code and shall attract action under Section 51 to 60 of the Disaster Management Act 2005.

National Directives for COVID-19 Management

- **Face coverings:** Wearing of face cover is compulsory in public places; in workplaces; and during transport.
- 2. Social distancing: Individuals must maintain a minimum distance of 6 feet (2 gaz ki doori) in public places.

Shops will ensure physical distancing among customers.

3. Gatherings: Large public gatherings/ congregations continue to remain prohibited.

Marriage related gatherings : Number of guests not to exceed 50.

Funeral/ last rites related gatherings : Number of persons not to exceed 20.

- **4. Spitting in public places** will be punishable with fine, as may be prescribed by the State/ UT local authority in accordance with its laws, rules or regulations.
- 5. Consumption of *liquor*, *paan*, *gutka*, tobacco etc. in public places is prohibited.

Additional directives for Work Places

- **6.** Work from home (WfH): As far as possible the practice of WfH should be followed.
- 7. Staggering of work/ business hours will be followed in offices, work places, shops, markets and industrial & commercial establishments.
- 8. Screening & hygiene: Provision for thermal scanning, hand wash and sanitizer will be made at all entry and exit points and common areas.
- **9. Frequent sanitization** of entire workplace, common facilities and all points which come into human contact e.g. door handles etc., will be ensured, including between shifts.
- 10. Social distancing: All persons in charge of work places will ensure adequate distance between workers, adequate gaps between shifts, staggering the lunch breaks of staff, etc.
