

Revised COTP 2020-21

Introduction

In the backdrop of COVID 19 pandemic, the COTP 2020-21 as approved by the Headquarters Office (Training Wing) had to be revised to make the courses suitable for Online Training and conducted through the Core Faculties available with the Training Institute.

In the process of revision, keeping in view of the instructions issued by Headquarters Office from time to time, the Revised COTP 2020-21 contains the courses already conducted/ being conducted since June 2020 and those being proposed to be conducted subsequently during the year 2020-21.

It may be mentioned that the instructions from the Headquarters Office (Training Wing) communicated through email dated 27.01.2019 required the following courses to be covered in the COTP 2020-21:

- 9 months training, including 3 months on job training, to the Direct Recruit AAOs,
- Mid-Career Training Programme for Group B officers (two weeks slots) in the second half of 2020-21,
- AAOs due for promotion in the cadre of SAO (2-4 weeks slots) in September 2020,
- RAE-2 revised paper on GST (one week slot) in August 2020,
- Courses on 'GST' and 'Audit of IT Environment' as per needs of the user offices.

However, the timeline indicated in the Headquarters' instructions had to be adopted in the context of prevailing Covid-19 situation. Further, approval of '**Mid-Career Training Programme for Group B officers**' and training to '**Direct Recruit AAOs**' from Headquarters Office is awaited.
