- 1. The transfer will not be in public interest and consequently no joining time, joining time pay & T.A. will be admissible.
- 2. The time spent in transit will be treated in accordance with C.I., MHA Dept. of per & A.R. O.M. No. 19011/33/81 Estt.(allowance) dated 29.01.1983 as incorporated in Govt. of India's decision No. 6 under para 10 of Appendix-10 [CCS(joining time) Rules] of FRSR Part-I.
- 3. He will be junior most in the Auditor cadre on the date of joining in the new office.
