- d) that the presence of the applicant outside India may, or is likely to, prejudice the friendly relations of India with any foreign country;
- e) that the applicant has, at any time during the period of five years immediately preceding the date of his application, been convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years;
- f) that proceedings in respect of an offence alleged to have been committed by the applicant are pending before a criminal court in India;
- g) that a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has been made by any such court;
- h) that the applicant has been repatriated and has not reimbursed the expenditure incurred in connection with such repatriation;
