This office wishes to appoint persons from Departmental Canteens of IA&AD for filling up of vacancies in following cadres in Departmental Canteen, O/o PAG(A&E), Bihar, Patna on deputation basis on usual terms and conditions stipulated in DOPT OM No. 6/8/2009-Estt.(Pay II), dated 17/06/2010 and amended from time to time. Deputation will be initially for a period of one year subject to further extensions on the basis of suitability of the deputationist(s) and other administrative convenience.


